The Retirement CEO is Retiring

Roberto L. Peña leaving ORS after 11 years as CEO



It's been more than 11 years and quite the adventure for Office of Retirement Services Chief Executive Officer Roberto Peña. Now, he has decided it's time to call it a career. Roberto's last official day will be in mid-August. He should depart with great pride at all he has accomplished alongside the two Plan Retirement Boards and a talented staff.

When Roberto came to City of San Jose ORS, the Plans faced a period of change. Like many public pension plans, significant adjustments were required to bring the system into compliance with various IRS rules and pension plan best practices.

"I guess I'd say that I'm most proud of two things," Roberto said, reflecting on the challenges of his tenure. "It sounds weird, but in pension administration, boring and steady-asshe-goes are good things. I feel I helped get us to that place and strengthen relationships between the City, the Boards, and members and staff. We grew more transparent, and more open with the media, our members and the public

"For more than eleven years Roberto has faithfully led San Jose's Office of Retirement Services, first as Director, and then as CEO. Over such a long tenure, he successfully navigated many changes: implementation of voter-approved Measure G, overhaul of the boards' governance structures, on-boarding entire generations of new trustees, and managing through the unprecedented upheaval of the Covid crisis. Under Roberto's management, ORS never missed a pension payment to a retiree. That is the ultimate testimony to his leadership. As chair, I will miss his support, good humor, and insight. We wish him well as he departs into his own, well-deserved retirement years."

Now, having come through the pandemic-driven challenges of continuing to run the office's business, dealing with the shell-shocked economic implications for the Funds, and finding a way to conduct accessible public Board meetings, Roberto sees this as a good time to retire.

In his young career, Roberto spent a decade conducting internal audits in the banking industry on the East Coast. He came to California in 1996, he worked for several other pension plans prior to joining San Jose where he had some extraordinary learning experiences.

Roberto accepted the San Jose position in February 2015 and says he has enjoyed every minute of it. "Believe it or not, after my wonderful staff, the thing I will miss the most is the public meetings – even the tensions and debates that go on about sometimes contentious issues."

Roberto and his wife, Lillian, want to travel and have booked a Mediterranean cruise in October. He hopes to relocate to Orlando, FL, where they have a second home, and possibly even serve on the retirement board for that City. For now, his priority is ensuring the smoothest transition possible for ORS and its members.



Hot Weather Safety Tips

- Drink plenty of water: Drink water even if you don't feel thirsty.
- Limit and void physical activity during the hottest time of the day—10 a.m.-3 p.m.
- Never leave people or pets in a closed, parked car.
- Stay in air-conditioned areas, whenever possible.
- Cool off by taking a bath or shower: Cool, plain water baths or moist towels work best.
- Wear cool clothing:
 Lightweight, light-colored and loose-fitting clothing can help you keep cool. Cotton clothes are good because they let sweat evaporate.
- Cover your head: Wear a wide-brimmed, vented hat or use an umbrella when outdoors because your head absorbs heat easily.
- Wear sunglasses and sunscreen: Use sunscreen with SPF 15 or higher when outdoors.
- Rest often in shady areas: Find shady places to cool down when outdoors.
- Check on frail or elderly family, friends, or neighbors often.

Quarterly Question

Q: What is COBRA? How does it work?

A: The Consolidated Omnibus Budget Reconciliation Act gives workers and their families who lost health benefits the right to choose to continue in their group plan and its benefits for limited periods of time. This applies under certain circumstances, such as voluntary or involuntary loss of a job, reduction in work hours, transition between jobs, death, divorce, and other major life events.

Here at ORS, the most common reasons for loss of health coverage are due to the loss of dependent child status under health plan rules or due to divorce. Some of ORS' health plans expire for dependent children on the last day of the month of their 24th birthday; others expire on the last day of the month of their 26th birthday.

P&A Group provides COBRA services for ORS, including options to make online payments and setup autopay. As part of their services, P&A will send an enrollment letter to dependents who are aging out of coverage or losing coverage due to a divorce. The letter advises them of their option to continue health coverage through COBRA. If the dependent would like to continue their coverage through COBRA, they must respond to P&A Group within 60 days of receiving the letter.

Please be aware that COBRA letters will come from P&A Group, not ORS, and they will be addressed to the dependent who is losing coverage. We've discovered that P&A's letters are sometimes confused with junk mail and thrown away in error. Since there is a strict 60-day enrollment window, it's important that the dependent receives the letter from P&A Group timely.

Members who qualify for COBRA must pay the entire premium for the coverage plus a 2% administrative fee. COBRA coverage continues for a maximum of 36 months.

San Jose Mineta International hits milestone

San Jose Mineta International Airport (SJC) recently celebrated 75 years of service to the Santa Clara County and Bay Area flying public, including our travel-happy members, both active and retired. Airport staff was kind enough to share a bit of history and the photo (above) of the airport's original staff and bungalowtype terminal to prove it. The very first flight landed in February, 1949, was a DC-3 operated by Southwest Airways (Delta Airlines original airline) carrying seven humans and 2,550 baby chicks. The chicks de-planed here in San Jose while the humans went on to Los Angeles. At the time, San Jose was a farm town of 95,000 residents. Today, San Jose is home to nearly 1 million people. During the late 20-teens, the airport was the fastest-growing in the United States. In 2023 SJC earned the title of Best Midsize Airport in the U.S. by the Wall Street Journal. Today, more than half a million passengers fly out of SJC per month and nonstop flights head off to 40 destinations. Happy Anniversary to our friends who serve us travelers out of SIC!
